Ms Margrete Stevens - Acting Lead Counsel, International Centre for Settlement of Investment Disputes

Margrete Stevens serves as Acting Lead Counsel of the World Bank Group's International Centre for Settlement of Investment Disputes. She has served as Secretary of the Tribunal in numerous arbitral proceedings brought under the ICSID Convention; under the ICSID Additional Facility Rules; and under the UNCITRAL Arbitration Rules. More recently she has been responsible for the day to day management of ICSID. Ms. Stevens also serves as a Member of the ADR Advisory Board of the International Law Institute, Washington, D.C.

Ms Stevens joined ICSID in 1989 after working for the United Nations High Commissioner for Refugees in Botswana and Malaysia.

Ms Stevens holds a Cand. Jur. degree from the University of Copenhagen and an LL.M. from London School of Economics. She is a member of the London Court of International Arbitration, the American Society of International Law and the International Bar Association. In 1995, Ms. Stevens and Professor Rudolf Dolzer published *Bilateral Investment Treaties* (Martinus Nijhoff).
