About the Speakers**Mr Silas Sng – Senior Assistant Director, OSH Policy & Legislation Branch, Ministry of Manpower**

Mr Silas Sng is currently the Senior Assistant Director in the OSH Policy and Legislation Department. Silas is a mechanical engineer by training and joined the Ministry in 1997. During his years with the Ministry, Silas oversaw the general safety and health matters in the manufacturing sector as well as in the field of lifting equipment. He was also involved in the drafting of some National Code of Practice under the auspices of SPRING Singapore. In 2003, Silas was awarded a Ministry scholarship to pursue a Master of Public Administration in the US. Since his return, Silas had been active in the area of OSH policy formulation.

He participated in the MND_MOM Construction Joint Review Committee that was set up in 2004 in the aftermath of the Nicoll Highway Collapse. Silas was also heavily involved in the drafting of the new Workplace Safety and Health Act (WSHA) and the various subsidiary legislation that were effected on 1 March 2006.

Mr Christopher Chuah co-heads the Building & Construction Practice and is a Partner in the China Practice. His main areas of practice encompass construction disputes, in both litigation and arbitration; and he is a specialist in Building and Construction Law.
