### About the Speakers (in speaking order)

#### **Ms Hairani Saban Hardjoe – Consultant, Chung Tan & Partners**

Hairani was called to the Singapore Bar in 1970 and practices in the areas of Trust, Estates & Probate, Finance and Security, Corporate Consultation & Documentation, Business & Commercial Documentation, Conveyancing, Landlord & Tenant and Intellectual Property. She has been in practice for 36 years, and has been a Legal Consultant to Chung Tan & Partners, Advocates & Solicitors since July 2003. Hairani has authored various books including:

- Real Property Financing In Singapore, published by Butterworths (Asia) (1988)
- Singapore Conveyancing Practice – Forms, Precedents & Materials, published by Butterworths (Asia) now Lexis Nexis, Butterworths (First published in 1992, Issue 10 published in 2002)
- Buying A Home – Sweet & Maxwell, December 2004.

She has also written numerous legal articles. Hairani is a presenter on "Sale & Purchase Agreement – The Contracting Process" at the National University of Singapore Extension Programme – 2004, 2005, 2006. She was also an Adjunct Professor at the Singapore Management University, Business Law Department for Term 2004 – 2005/2 in Real Estate Law.

#### **Mr Ernest Balasubramaniam – Director, Arfat Selvam Alliance LLC**

Ernest Balasubramaniam graduated from the National University of Singapore with an LLB (Hons) degree. Ernest was admitted as an Advocate & Solicitor of the Supreme Court of Singapore in 1990. He then obtained his LL.M. from the National University of Singapore in 1992 where he read advanced Banking Law, International Business Transactions, Insurance and Tax.

Ernest commenced private practice in June 1993 as a partner with a Singapore firm primarily involved in banking and commercial real estate matters.

He currently heads the Corporate Real Estate practice of Arfat Selvam Alliance LLC.

Ernest enjoys a broad practice, which includes conveyancing, general corporate, banking, project finance, tax and civil litigation and arbitration. He has also acted as instructing counsel in cross-border disputes involving the United Kingdom, the British Virgin Islands and the United States of America. He has also advised several REIT transactions locally.

He frequently advises major institutional clients including the CPF Board, Banks, Real Estate Developers and both private and listed companies.

#### **Mr Gan Hiang Chye – Partner, KhattarWong**

Mr Gan Hiang Chye is the Head of Banking, Finance & Property Department. He has been an advocate and solicitor for over 30 years. He worked as a government legal officer in various postings, namely: Deputy Public Prosecutor/State Counsel, Magistrate, Deputy Registrar at the Registry of Land Titles and Deeds and Deputy Controller of Residential Property at Land Dealings (Approval) Unit. In 1977, he entered private practice and has since acted as counsel in arbitration proceedings and in many cases heard by the High Court and Court of Appeal, in particular relating to banking and conveyancing matters such as land disputes and enforcement of securities. He is an Arbitrator on the Panel of Arbitrators of the Singapore Institute of Arbitrators.

He is active in the Law Society of Singapore and is the Chairman of the Conveyancing Practice Committee. He is also the Deputy President of the Strata Titles Boards and was awarded the Public Service Medal for his work. He is currently a Board member of the Building Construction Authority.

#### **Ms Wendy Wong – Director, Sim & Wong LLC**
