Mr Tackaberry was called to the Bar of England and Wales (Grays Inn) in 1967. In 1982, he was appointed to be one of Her Majesty's Counsel (England & Wales). He was a Recorder of the Crown Court from 1988-2005. From 1998-2003, Mr Tackaberry was a Commissioner of the United Nations Compensation Commission (until July 2003). He is a

principal editor of the Handbook of Arbitration Practice and a Principal Editor of Bernstein, Handbook of Arbitration and Dispute Resolution Practice.

Mr Tackaberry's positions and memberships include:

1. Past Chairman of the Chartered Institute of Arbitrators and first chairman of its Executive Committee
2. A principal architect of the Chartered Institute of Arbitrators' international activities and of its Special Fellowship courses
